ORDER:

Orders were issued in the G.O. 5th read above, notifying certain species in the schedule-II of Telangana Forest Produce Transit Rules, 1970.

- 2. The Farmers of Wanaparthy, Warangal & Janagaon their representations 6th read above, have requested the Government to include Neem, Acasia Species, Raavi and Neredu specie in Schedule-II exempting from obtaining permissions for transportation permit etc., due to which they are facing problems for transportation of the above said categories of trees for obtaining transit permits grown in their own fields.
- 3. Government after careful examination of the matter taking into consideration of the request of the farmers hereby decided to include the four specie namely (i) Neem (Azadiracta indica), (ii) Nalla Tumma (Acacia nilotica), (iii) Ravi and related species (Ficus species) and (iv) Neredu (Syzigium cumini) in the Schedule-II under Rule 16 of Telangana Forest Produce Transit Rules, 1970 in addition to the existing specie, notified in the G.O. 5th read above.
- 4. Accordingly, the following notification shall be published in an extraordinary issue of the Telangana State Gazette Dated: 20.02.2018.
